GUIDELINES FOR SUBMISSION (All submissions are refereed):

- Submissions must not have been published, submitted or presented at other conferences.
- The full paper should be a maximum of fifteen single-spaced pages including references and exhibits. Requirements for the paper formatting and abstract: **Page:** A4; **Font:** Times New Roman, **Size:** 12 pt; **Paragraph:** Line spacing single; **Page Setup:** Margins: Left: 4; Right: 4.5; Top: 6; Bottom: 3.5.
- Abstracts should be a maximum of one single-spaced page and up to four key words that describe your paper.
- The name(s) of the presenting author(s) and other co-author(s), affiliation(s), complete mailing address(es), telephone/fax numbers and e-mail address(es), title of the paper should be filled in the Application Form.
- Special scheduling requests (dates or times) must be made at time of paper submission.
- Electronic submissions are expected. Submissions should be in Microsoft Word format. In the **subject** should be written: ASECUCONF. (*name of the leading author*)
